### Footnotes

GRACE ALLEY lacked speed, circled the far turn, angled to the four path in upper stretch, moved to the lead inside the eighth pole and was ridden out. INDIAN SUGAR showed no speed, swung wide in midstretch and rallied. PURE LIGHT moved up three wide on the far turn, had aim on the lead in midstretch but failed to sustain her bid. CAT N CABOODLE sped to the front, saved ground setting the pace and gave way in the drive. MUSICAL MANDATE saved ground and weakened. REINE DE BONBON chased the pace two wide and gave way in midstretch. EAT CAKE, wide the first turn, was outrun. SPRING PROM was outrun. KASABLANCA EXPRESS chased the pace, faltered and was eased.
