DANIELE MA BELLE , unhurried early, eased out five wide entering the stretch, closed nicely and drew clear. FLASHY JAZZY , bumped by SUPER ANNETTE leaving the starting gate, was hustled to the front, set the pace slightly off the rail and gave way grudgingly. DIZZY TURPENTINE , three wide, chased the pace in a willing effort. DAYLIGHT FIRE lacked speed, swung four wide entering the stretch and rallied. DAY FOR DAY lacked speed, swung eight wide for room entering the lane and passed faders. RIGHT ON GO bore in leaving the starting gate, chased the pace and gave way in the drive. REAL GOLD hugged the rail and was no factor. THREE D ALYCAT , seven wide at the head of the stretch, was not a factor. LIKewise , outrun, was steadied on the heels of a rival near the three eighths pole. LEADING LADY , bumped leaving the starting gate, raced wide entering the stretch and weakened. SUPER ANNETTE bore out ,leaving the starting gate, chased the pace two wide and faltered.
