OUTER TURF FOR TWO-YEAR OLDS. . No nomination fee. \$250 to enter and \$250 additional to start. Supplementary nominations may be made at the time of entry Monday, July 12, 2010 by payment of \$2,500 each (includes all fees) \$50,000 Guaranteed. After payment of 1% to all owners of horses finishing 6th through last, 60% of the remaining purse shall be paid to the owner of the winner, 20% to second, 11% to third, 6% to fourth, and 3% to fifth. Weights: 120 lbs. Non-winners of a sweepstake allowed 2 lbs.; of two races other than maiden or claiming, 4 lbs; a race other than maiden or claiming on the turf 6 lbs. Starters and riders must be named through the entry box by the usual time of closing. This race will be limited to fourteen (14) starters. Preference to start will be given in the following order: Graded/Group Stakes Winners (in order I-II-III). Stakes winners, then highest lifetime earnings. Failure to draw into the race cancels all fees. Trophy to the winning owner. Nominations closed on Tuesday, July 6th, 2010 with 32 nominations.

Z APPEAL settled off the pace along the rail, swung three wide leaving the five-sixteenths pole, came five wide into the lane, made a quick bid in upper stretch, took the lead in midstretch and drew off while drifting out under a constant right-handed drive. THE FLYING WHIZZER was unhurried along the rail around the turn, advanced inside in upper stretch and gained the place in deep stretch. HAPPYTHEMAN settled off the duel while racing in the two path, advanced four wide just outside of the winner nearing the lane then flattened out in the drive. ROAR AS THE WYNNND dueled along the rail, dropped back a bit nearing the lane then kept trying while racing between rivals to the wire. VALTER lacked speed three wide around the turn, swung to the far outside in upper stretch and rallied belatedly. UNBRIDLED TUNE raced four and five wide around the turn and never factored. OL' MAN MURPH dueled outside around the turn, drew clear nearing the lane then tired in upper stretch. SOLITARY SUNSHINE chased the pace while racing three wide around the turn and came up empty in the drive. LIPSTICK TRACES was outrun inside. WATCHTHICKICK was never a factor.
