PAIR was rated back inside early, angled out mid turn, surged between rivals in mid stretch and eagerly kicked clear under a drive. FREDRO disputed the pace three wide, drew clear in mid stretch and stayed on well to save the place. HELLO HOLLYWOOD saved ground, was lightly steadied advancing near the quarter pole, angled out then back to the rail and finished well. MONTY'S APPEAL rated in range, between rivals mid turn, angled out four wide advancing into the stretch, loomed in mid stretch then hung. GAVAN'S REPENT was rated back from between rivals soon after the break, lagged back, swung very wide and failed to generate the needed kick. MAD REBEL, four wide chasing the pace, made a mild run into the lane then flattened out. MAMMOTH LAKES, wide, failed to rally. BODYNE failed to menace. OVERLAP dueled inside rivals, held a short lead nearing the lane, held well to mid stretch then tired. JUST HILLBILLIE vied between rivals early and tired. RIDDLER AND RHYMES, wide, was outrun.
