**Footnotes**

MAXIMIZE , patiently rated, moved closer leaving the far turn, rallied between rivals leaving the three sixteenths marker, lightly brushed UNTOPABLE near mid stretch, took command nearing the sixteenth marker then dug in gamely to prevail. FLYING PEACE , unhurried early, saved ground leaving the far turn, angled out entering the lane, advanced between rivals leaving the sixteenth marker and finished gamely inside of the winner. UNTOPABLE , well placed in hand off the rail down the backstretch, advanced four wide nearing the lane, was brushed in mid stretch, finished willingly but was outfinished for the place. TUFF LOVER , taken to rate, saved ground into the lane, angled out, steadied in traffic in mid stretch, angled back in and finished willingly. PALM BEACH BUD cleared early and angled to the rail, dueled down the backstretch, rated back leaving the far turn and eased out, moved three wide to command in upper stretch, briefly went clear then weakened late. KATABLASTIC , unhurried early, came six wide for the drive and lacked a solid bid. SUNSHINE NUMBERS angled out early and lodged a two wide bid early backstretch, dueled, went clear leaving the far turn, was collared near the quarter pole, battled to mid stretch then weakened. Following a stewards' inquiry and objection by the rider of UNTOPABLE, MAXIMIZE was disqualified from first and placed third for interference in the stretch.
