Non-winners of \$35,000 twice at a mile or over allowed 3 lbs.; \$35,000 at a mile or over, 5 lbs.; \$25,000 or a race at a mile or over other than Maiden, Claiming or Starter, 7 lbs. Graded placed horses of equal weights preferred. A trophy will be presented to the winning Owner. One (1) Supplemental Nomination of \$3,000 to enter and start. Closed Saturday, December 16, 2006 with (28) nominations. (If deemed inadvisable to run this race over theTurf course, it will be run on the main track at One Mile and One Eighth).




Footnotes

SOLDIER'S DANCER rated off the pace toward the outside, started his drive four wide into the final turn, entered the stretch angling six wide and closed steadily to draw clear late yards. SEDGEFIELD rated with the pace two deep, moved to even terms approaching the quarter pole, came in making light contact with Storm In May soon after entering the stretch, dueled to a short brief lead in deep stretch but outfinished the closing yards. STORM IN MAY advanced to a short lead inside, was pressured into the lane, brushed while dueling with a slight lead from there and yielded toward the wire. RUTLEDGE CAT rated off the pace and off the hedge, was boxed between and behind rivals on the final turn then finished evenly. DELIGHTFUL KISS rated off the pace outside, bid four wide into the final turn then weakened through the lane. ON MY DIME, unhurried inside, bid entering the stretch and finished evenly. PICKAPOCKET rated close just off the hedge, gave chase skimming the hedge toward the quarter pole then faded midstretch. LOOSE LEAF raced boxed in through the opening turn, gave chase on the final turn and proved empty for the drive. NORTHERN ACADEMY, outside early, rated back and weakened into the lane. The stewards reviewed a claim of foul against the rider of the runner-up by the rider of the third place finisher but found no cause for disqualification.
