NIAM'S STRIKE stalked the pace three wide, rallied to take over soon after entering the stretch, then drew off under urging. QUIET DANGER stalked the pace along the inside, steadied from inside LIQUID LUCK at the eighth pole, then was no match for the winner while closing to be up for the place. LIQUID LUCK set the pace off the rail into the stretch and gave way. RED ZONE FLYER unhurried early, circled rivals four wide around the far turn to loom a threat entering the stretch, then tired. SKIFFS BREWMEISTER rated off the pace, saved ground and faltered. CALL ME MIGHTY raced three wide and dropped back. COUNTRY CHAMP tracked the pace into the far turn, then was fading when steadied on that turn. ACT OF WAR (IRE) reserved off the pace, steadied from close quarters on the far turn and had nothing left.
