LEAVE IT TO BERN rated off the pace, rallied four wide around the far turn, moved to take over at the eighth pole, then drew away under urging. FINANCIAL PATHWAY outrun early, raced four wide around the far turn and rallied to be up for the place. TWIN stalked the pace off the rail, moved to take over on the far turn, made the pace to nearing the eighth pole, then gave way. TIZAWONDERFULLIFE tracked the pace three wide to nearing the stretch, then tired. WAT failed to menace. CRIME FAMILY saved ground and never threatened. VIA MARINA chased the pace three wide to the top of the stretch,

then faltered. DISTINCTIVE MOVE set the pace along the inside to nearing the quarter pole, then had nothing left. CONCORDE EXPRESS pressed the pace outside DISTINCTIVE MOVE into the far turn and faded. SOLICITATION was through after a half mile. MY OMEGA RUN was done early and eased in the stretch run.
