Footnotes

PETCH bumped with PEACE AT DAWN at the start, vied for the lead along the inside, opened a clear lead in midstretch, then dueled with STRONG FIRE when challenged by that rival late and prevailed. STRONG FIRE bumped between rivals at the start, tracked the pace, swung out for the stretch run, then rallied to duel with PETCH late and just missed. PEACE AT DAWN rated off the pace after being squeezed between rivals at the start, raced four wide around the turn and closed to be up for the show while no threat to the top ones. PURELY PRECIOUS broke in bumping STRONG FIRE contributing to crowding, then vied for the lead three wide around the turn and gave way. CZECH MASTER bumped between rivals at the start, vied for the lead between horses to midway of the turn, then tired. TRUMP CARD bumped between rivals at the start, saved ground and was not a factor. THE RIDER OF TRUMP CARD LODGED AN OBJECTION AGAINST THE RIDER OF PETCH FOR ALLEGED INTERFERENCE SOON AFTER THE START. THE CLAIM OF FOUL WAS NOT ALLOWED.
