CAJUN BREEZE showed speed off the rail into the stretch, then was fully extended to hold sway. ON APPEAL rated off the pace, advanced three wide around the turn to reach the attending position but couldn't gain on the winner late. INDIRECTLY A. P. reserved off the pace, passed tired rivals for the show. HOUSTON BULL chased the pace three wide around the turn and tired. THE FED EASED showed some early foot along the inside and faltered. CAPITAL CITY well placed early, faded.
