TOP HILL reserved early, rallied three wide on the far turn to take over entering the stretch and opened a clear lead, then remained clear to the wire under urging. SEND THE PACKAGE rated off the pace, checked in behind CRAZY CARO on the far turn, recovered and rallied to be up for the place. DUCHESS COUNTY unhurried while saving ground, steadied entering the far turn, then closed well along the inside in the drive to just miss the place. SPICY LIGHT allowed to settle, improved her position in the drive without threatening. INLET MOON tracked the pace, angled out in the stretch and tired. OLD MOTHER GOOSE was not a factor after being squeezed back from between rivals in the early going. VOLUNTOWN showed speed along the rail, sprinted clear racing down the backstretch, made the pace to the top of the stretch and gave way. EVENING ENCORE (GB) showed early foot, raced three wide on the far turn and faltered. CRAZY CARO chased the pace after being outrun for the lead on the backstretch, made a run to reach VOLUNTOWN on the far turn, then was checked from between rivals at the quarter pole and faded. The riders of SEND THE PACKAGE and CRAZY CARO lodged objections against the rider of TOP HILL for alleged interference on the far turn. The claims of foul were not allowed.
