MR. LIVINGSTON unhurried early, steadied on the far turn to avoid running up on DIABLO REIGNS, angled out four wide to make his run, rallied to take over at the eighth pole and drew clear. TOUR OF THE CAT made the pace along the inside to midstretch, then couldn't match strides with the winner while holding the place. UNITE'S BIG RED reserved racing along the rail, was attempting to get through inside TOUR OF THE CAT on the far turn when caught in tight and checked, then had no late response. MARQUETTE failed to menace. DIABLO REIGNS pressed the pace outside TOUR OF THE CAT into the far turn and tired. The rider and trainer of UNITE'S BIG RED lodged objections against the rider of TOUR OF THE CAT for alleged interference on the far turn. The claims of foul were not allowed.
