### Footnotes

FOOTPRINTINTHESAND bumped with MRS HALLIGAN at the start, showed speed along inside into the stretch, then drew clear under urging. CINDY CATA pressed the pace outside FOOTPRINTINTHESAND around the turn, came out a bit at the top of the stretch, then couldn't match strides with that rival in the drive while proving best of the rest. THERIAULT PASS chased the pace three wide, made a run at the winner on the turn, then tired in the drive. BUMBA BUMBA saved ground and failed to menace. GLACKEN ROAD saved ground and never threatened. MOON SPARKLES tracked the leaders three wide to nearing the stretch, then tired. GENERATIONS Y showed little. FLO'S A GO raced three wide and faltered. MRS HALLIGAN was outrun after bumping with FOOTPRINTINTHESAND at the start. THE RIDER OF CINDY CATA LODGED AN OBJECTION AGAINST THE RIDER OF THERIAULT PASS FOR ALLEGED INTERFERENCE AT THE TOP OF THE STRETCH. THE CLAIM OF FOUL WAS NOT ALLOWED.
