INDULGENCE reserved off the pace after breaking slowly, angled out for the stretch run, rallied to gain command approaching the sixteenth pole and won going away. AFLEET LASS chased the pace three wide into the stretch and closed to be up for the place while being outfinished by the winner. BELIEVEINTHEMOMENT tracked the pace along the inside, angled out in the stretch and closed to just miss the place. REDFOXLEY DOROTHY chased the pace off the rail to inside the eighth pole and weakened. FLY EXPRESS showed speed along the rail to nearing the sixteenth pole, then gave way. MY PRECIOUS BABY rated in striking position off the pace, lacked a late response. BOND BARONESS failed to menace. SHIFT IT was no factor while racing three wide. ON APPROVAL broke slowly, then drifted out on the turn and was outrun. GIRL BAR lunged at the start unseating her rider. There was a stewards inquiry into the fallen rider.
