WINNER JAK unhurried early, rallied three wide to take over on the far turn, then drew off. TRUST THE DEPUTY outrun early, raced three wide around the far turn and closed to be up for the place while no match for the winner. STRAIGHT THUNDER reserved off the pace, advanced four wide around the far turn to reach contention but couldn't keep pace with the winner while being outfinished for the place. MATCHING WHITES rated off the pace, advanced to loom a threat on the far turn, then gave way. GO GO GO failed to menace. PROMO chased the pace to midway of the far turn, then tired. FEARLESS HONOR hit the gate at the start, tracked the pace for a half mile, then faltered. I'M DANCING TOO reserved along the inside, hit the hedge leaving the far turn and failed to recover. WAT set the pace, drew clear racing down the backstretch, made the pace into the far turn and faded. DIXIE NEWMAN off slowly, was outrun. LIFE BAND showed brief speed, stopped racing into the far turn and was eased.
