Footnotes

MEADOW ASHLEE chased the pace, rallied to catch EMMA'S CANDY at the top of the stretch, then drew off under urging. EMMA'S CANDY set the pace along the rail to the top of the stretch, then was no match for the winner. GLITZZY GLIDER tracked the pace three wide into the far turn and tired. JEAN DE ACTRESS was no factor after being bumped and steadied between rivals entering the first turn. MADISON NORTH bumped between rivals entering the first turn, raced three wide around the far turn and faltered. PAGO ISLAND rated off the pace after bumping with JEAN DE ACTRESS entering the first turn, faded leaving the far turn. CLOSE THAT EVENT veered out entering the first turn to avoid running up on the bumping incident, was outrun and eased in the final eighth. LEVY LIGHT bumped with MADISON NORTH entering the first turn, stopped abruptly on the far turn and was pulled up in the stretch.
