PETER BOY chased the pace off the rail, rallied to take over from STAMEN in the stretch, then drew clear under urging. STAMEN showed speed along the inside, responded headed by PETER BOY in the stretch, then yielded late. LIL JOHN PAUL chased the pace along the rail into the stretch and weakened. SOLAR D'ORO failed to menace. HIT THE CYCLE was not a factor. MARTY'S PERFECT broke poorly, then saved ground to no avail. OMEGA RISING rated off the pace, raced three wide around the turn and tired. ORO VERDADERO off slowly, raced four wide and faltered. THE RIDER OF STAMEN LODGED AN OBJECTION AGAINST THE RIDER OF PETER BOY FOR ALLEGED INTERFERENCE IN THE STRETCH. THE CLAIM OF FOUL WAS NOT ALLOWED.
