HISTORYOFASAINThurried after hitting the gate at the start, raced four wide around the far turn, swung out widest of all for the stretch run and rallied to be up late. MR. RACHIN stalked the pace three wide, rallied to take over at the eighth pole and continued on with good courage while unable to resist the winner in the closing strides. SANCTION rated off the pace after stumbling at the start, steadied in behind rivals on the far turn, was still blocked in behind rivals when he clipped heels in the stretch, recovered and rallied to just miss the place. MOUNTAIN MYTH well placed along the rail after being caught in tight at the start, slipped through inside MIA CONCERTO in the stretch to loom a threat but didn't do enough late. CHARKO allowed to settle, raced four wide around the far turn, steadied when caught in tight at the eighth pole, then improved his position without threatening. TRIAL bumped with ANDYCAT at the start, raced three wide on the far turn, was caught in traffic in the stretch and had no response when asked. ALARMING AFLEET reserved off the pace, advanced four wide around the far turn to reach contention in the stretch, then gave way. ANDYCAT bumped with TRIAL at the start, chased the pace, moved to gain a slim lead on the turn, then tired in the drive. MIA CONCERTO stumbled at the start, sprinted to a clear lead along the inside, responded when ANDYCAT moved to fore on the far turn, continued on well to the eighth pole, then faltered. TAMAZUNCHALE was not a factor.
