TRIPPI'S SAILOR chased the pace three wide, rallied to take over inside the eighth pole, then drew clear under urging. STORM TEASE vied for the lead along the rail to the eighth pole, then couldn't stay with the winner while saving the place. BELIEVEINTHEMOMENT reserved racing along the rail, steadied when caught in tight midway of the turn, angled out and closed to just miss the place. CHEECA STORM allowed to settle, advanced to reach contention in the stretch but couldn't gain late. CARA'S SONG rated off the pace, raced three wide around the turn and lacked a late response. HALCYON DAYS vied for the lead outside STORM TEASE to the eighth pole, then gave way. AROMA DE MUJER was vying for the lead between horses when steadied from close quarters entering the turn, then tired.
