MY MAN DAN broke awkwardly, pressed the pace three wide, moved to take over leaving the turn and opened a clear lead, then was fully extended to hold off HOT SPEED. The latter, broke slow and was forced in by TOUR DE COMPRISE at the start, chased the pace along the rail into the stretch, angled outside MY MAN DAN and closed with a mild rally. MARTY'S PERFECT reserved racing three wide, couldn't keep pace with the top ones in the drive while gaining the show. CHICKEN PICKER well placed to midway of the turn, tired. TOUR DE COMPRISE was no factor after ducking in at the start. NO BAD BEER FACE showed speed off the rail to nearing the stretch, then faded. The rider of HOT SPEED lodged an objection against the rider of MY MAN DAN for alleged interference in the stretch. The claim of foul was not allowed.
