### Footnotes

ODE TO ROY rated a clear pace inside, lost some ground entering the stretch but widened under competent handling when straightened away. CAIXA ELETRONICA, steadied at the start, was allowed to settle off the early pace inside, closed toward contention nearing the turn, eased outside the pacesetter entering the lane then lacked a sufficient stretch response. POST TIME settled off the pace and off the rail, made a three wide bid into the turn then leveled off in the stretch. STARSHIP DESTROYER chased the pace about the three path but weakened from the three eighths pole. PUNTO FIJO (URU) and GEORGIAN were not factors. WOODLAND, with the early pace while between horses, faded through the turn.
