Footnotes

UNBRIDLED FUTURE chased the pace, slipped through inside PRIVATE PREMIER to gain the lead midway of the far turn, eased out for the stretch run, then came in intimidating the rider of GENERAL GUTI inside the sixteenth pole and drew clear. GENERAL GUTI tracked the pace along the rail, made a run at the winner in the stretch, was steadied from inside that rival just past the sixteenth pole, then couldn't stay with that one while holding the place. ARCH THIRTEEN reserved off the pace, advanced into contention four wide around the far turn but had no further response. HUTTER prompted the pace three wide to midway of the far turn, then gave way. SIR STRIKING unhurried after being bothered by MACHO'S WILDCAT at the start, advanced three wide around the far turn to reach contention, then tired in the drive. SUPER STRESSED steadied to avoid MACHO'S WILDCAT at the start, raced three wide and faltered. RUNAWAY DEPUTY was outrun. DIVINE COLONY was never a factor. PRIVATE PREMIER set the pace off the rail to midway of the far turn, then had nothing left. MACHO'S WILDCAT broke to the outside, chased the pace four wide into the far turn, then faded. The rider of GENERAL GUTI lodged an objection against the rider of UNBRIDLED FUTURE for alleged interference inside the sixteenth pole. The stewards determined the incident had no effect on the outcome and the claim of foul was not allowed.
