RICK THE BARTENDER chased the pace off the rail, moved up to engage JULIANNA'S COUSIN on the turn, vied with that rival to past the eighth pole, then drew away. YES HE'S INNOCENT chased the pace off the rail, angled out for the stretch run and closed to be up for the place while no match for the winner. JULIANNA'S COUSIN showed speed along the inside, responded when challenged by RICK THE BARTENDER on the turn, vied with that rival to past the eighth pole, then gave way. GO TO THE NET allowed to settle, raced in contention along the inside into the stretch but had no late response. HEART TRUST failed to menace after being steadied at the start. A. F. HENNESSEY rated off the pace, tired in the drive. WHATSUPNOTMUCH was done early. BLACK JACK COUNTY showed early foot along the rail, faded and was eased in the stretch run.
