### Footnotes

GROVE HALL unhurried early, advanced into contention around the far turn, was rallying to gain the lead when he came in for a couple of strides at the eighth pole, then drew clear. DRAMON chased the pace, inherited the lead when STINGING bolted, made the pace along the inside to nearing the eighth pole, then couldn't stay with the winner while holding the place. DSPITE ALL MY RAGE tracked the pace along the inside, eased out in the stretch, then was steadied nearing the eighth pole, recovered and finished willingly. J W B'S CHOICE rated off the pace, advanced along the inside to loom a threat in the stretch, then flattened out. RATTLESNAKE RED stalked the pace, made a run at DRAMON on the far turn, then tired in the drive. RIO GREY failed to menace. ALO ALO MARCIANO saved ground and was done early. STINGING set the pace along the rail, then bolted to the outside hedge soon after entering the backstretch and was pulled up. There was a stewards inquiry and the rider of DSPITE ALL MY RAGE lodged an objection against the rider of GROVE HALL for alleged interference in the stretch. The claim of foul was not allowed.
