RED ZONE FLYER rated off the pace, raced four wide around the turn, rallied to catch MALIBU WAVE inside the eighth pole, then drew away. MALIBU WAVE showed speed off the rail, drew well clear around the turn, made the pace to past the eighth pole, then was no match for the winner while holding the place. ROYAL JOKESTER tracked the pace off the rail, then couldn't keep pace with the top one while gaining the show. DANCING FOR LOIS reserved off the pace, raced three wide around the turn, then steadied in early stretch and tired. BISHOP'S LODGE tracked the pace to midway of the turn, then faltered. REIMBURSER chased the pace along the inside into the turn and faded. ADAMS REYE'S was not a factor. ERUPTION ZONE was outrun. DADDY AGAIN showed little and was eased in the final eighth. THE RIDER OF DANCING FOR LOIS LODGED AN OBJECTION AGAINST THE RIDER OF ROYAL JOKESTER FOR ALLEGED INTERFERENCE IN EARLY STRETCH. THE CLAIM OF FOUL WAS NOT ALLOWED.
