JILL'S DANCER bumped between rivals at the start, tracked the leaders three wide to nearing the stretch, then couldn't keep pace in the drive. JOANN'S APPEAL bumped JILL'S DANCER at the start, showed early foot and faltered. I'M A FLIRT was no factor after being bumped and squeezed back at the start. PUT IT ON A JET off slowly, raced four wide and dropped back. FRENCH CAFE saved ground and faded. BLAZING EXIT trailed after breaking poorly.
