MALIBU WAVE bumped by BILLOS BOY at the start, pressed the pace three wide, moved to take over midway of the turn, then drew off while being kept to pressure. BILLOS BOY broke out bumping PUTY BOY soundly at the start, continued to come out to bump MALIBU WAVE, pressed the pace between rivals to midway of the turn, then was no match for the winner while drifting out in the stretch and holding the place. HUMOR ME DOC rated off the pace, passed tired rivals to be up for the show. BEA TOP QUALITY broke a step slowly and failed to menace. PUTY BOY was steadied when knocked into CONCORDE EXPRESS at the start, saved ground and tired. RICHARD CROY showed speed along the rail to midway of the turn, then faltered. CONCORDE EXPRESS steadied when bumped hard at the start, raced three wide and faded. MY MASS MEDIA tracked the leaders four wide into the turn, then had nothing left. FOLLOWING A STEWARDS INQUIRY, BILLOS BOY WAS DISQUALIFIED AND PLACED SEVENTH FOR INTERFERENCE TO SEVERAL RIVALS AT THE START.
