**Footnotes**

ROMACACA set the pace along the hedge into the stretch, drifted in and out inside the eighth pole, then was fully extended to prevail. TRIP FOR A. J. stalked the pace along the hedge, angled outside ROMACACA inside the eighth pole but couldn't get to that rival while proving best of the rest. PERFORMING prompted the pace outside ROMACACA to nearing the stretch, then weakened. DANCIN PERFECT reserved early, angled out for the stretch run and gained some ground without threatening. SHE'S A KETCH rated in striking position off the pace, had no response in the drive. RULING CLASS tracked the pace three wide into the far turn and gave way. DANCING RAGE was never a factor. The rider of TRIP FOR A.J. lodged an objection against the rider of ROMACACA for alleged interference in the stretch. The claim of foul was not allowed.
