VENTANIA unhurried while saving ground, angled out leaving the far turn, rallied to catch MISS MUFFIN inside the eighth pole and drew away. GATOR'S TRACKS rated off the pace, steadied when caught in tight along the rail on the first turn, continued to save ground, angled out for the stretch run, then rallied to be up for the place while no match for the winner. MISS MUFFIN chased the pace, moved to take over leaving the far turn, made the pace to past the eighth pole, then gave way. HOT CAPPUCINO set the pace along the rail to nearing the stretch, responded when MISS MUFFIN moved to the fore, then tired in the final eighth. MINI MOM failed to menace. DAWN'S SONG rated in striking position off the pace, faltered on the far turn. BOBBIESQUEEN chased the pace three wide to midway of the far turn, then faded.
