### Footnotes

COUNTY MADAM chased the pace, raced a bit greenly while rallying to take over nearing the sixteenth pole, then was all out to hold off DREAMS OF DIXIE. The latter, tracked the pace, swung out for the stretch run and rallied to just miss. SHE'SATHINK'N tracked the pace along the rail, steadied and angled outside COUNTY MADAM inside the eighth pole, then steadied again when DAZZLING HALO drifted in front of her at the sixteenth pole, recovered and was gaining at the finish. DAZZLING HALO showed speed off the rail to inside the eighth pole, then drifted in a bit approaching the sixteenth pole and weakened. LOGAN SQUARE chased the pace three wide into the stretch but didn't do enough late. ANOTHER REGRET steadied in the early going and failed to menace. EMMA'S KNIGHT off slowly, was not a factor. The rider of SHE'SATHINK'N lodged an objection against the rider of COUNTY MADAM for alleged interference in the stretch. The claim of foul was not allowed.
