STARSHIP WILDCAT set the pace along the inside, responded when JAMIE'S BOY made a run at him on the backstretch and reopened a clear lead, made the pace into the stretch and remained clear to the wire under urging. JAMIE'S BOY chased the pace, made a run at STARSHIP WILDCAT on the backstretch but couldn't stay with that rival while continuing on with good courage to prove best of the others. KID CURRY reserved off the pace, raced three wide around the far turn and finished willingly to be up for the show. DREAMING OF DANNY chased the pace three wide, then drifted out bothering ONE GOLDEN ROAD in midstretch, then didn't do enough late while being edged for the show. ONE GOLDEN ROAD rated off the pace, angled out for the stretch run, then steadied when bothered by DREAMING OF DANNY and gained some ground without really threatening. ECLIPTICALSPRALINE stalked the pace along the rail into the stretch and gave way. TANNERSVILLE trailed. FOLLOWING A STEWARDS INQUIRY, DREAMING OF DANNY WAS DISQUALIFIED AND PLACED FIFTH FOR INTERFERENCE TO ONE GOLDEN ROAD IN THE STRETCH.
