YOU GLITTER GIRL sprinted to a clear lead along the inside, responded when challenged from both sides in the stretch and was all out to prevail. COVINCING chased the pace, made a run at the winner through the stretch but was outgamed to the wire. R OBSESSION reserved early, rallied along the hedge to reach the leaders in the stretch and hung. STAVINSKY'S GAL rank under restraint in the early going, raced in striking position into the stretch, then tired. ADREALITY stumbled and bumped soundly with LYNI DE LOU at the start, raced in contention into the far turn and faltered. STORMIN' DAINA unhurried early, raced four wide on the far turn and never threatened. MIRACLE RUNNER chased the pace three wide into the far turn and gave way. SO MUCH MORE failed to menace. SNIFFLES was outrun. SKIP COMMAND off slowly, was not a factor. LYNI DE LOU was through early after being bumped hard at the start.
