Footnotes

BARBARO'S REVENGE stalked the pace, angled out leaving the far turn and rallied with MAXIMOSO to be just up at the wire. MAXIMOSO rated off the pace after breaking slowly, eased out leaving the far turn and rallied with BARBARO'S REVENGE to just miss. ALPHA GLITTER unhurried early, raced four wide around the far turn and closed well to just miss catching the top ones. MIMITO BOY set the pace along the rail, drew well clear in the stretch, then ducked in at the gap inside the sixteenth pole and yielded. WILD RATE outrun early, improved his position without threatening. FLYIN TREY chased the pace into the stretch, then tired. ICY STRAIT off slowly, was outrun. RAPID RUNNER was not a factor. SCOTTISH COAST showed brief speed, chased the pace three wide to midway of the far turn, then tired. RASCALLION was through after a half mile.
