DIVINE COLONY unhurried early, raced four wide around the turn, rallied along the outside to gain the lead nearing the sixteenth pole, then drew clear. VERIFICADOR off slowly after breaking through the gate prior to the start, chased the pace three wide, made a run to reach near even terms for command in the stretch but couldn't match strides with the winner while continuing on with good courage for the place. LAVISH ROMAN ducked out at the start, chased the pace, moved to take over on the turn, made the pace to nearing the sixteenth pole, then gave way. DADDY DE DE chased the pace along the rail to inside the eighth pole, then tired. HEZANELITE tracked the pace around the turn and faltered. TONK showed speed along the inside to midway of the turn, then faded. TOMMY'S CLOSING stumbled at the start unseating his rider. There was a stewards inquiry into the lost rider.
