TRUMP CARD unhurried while saving ground, angled to the outside in the stretch and rallied to be just up at the wire. KIPPY KAT showed speed off the rail, drew well clear in midstretch, then shortened stride late and couldn't resist the winner at the wire. CANDI'S HALO pressed the pace along the rail, then bumped with LIL JOHN PAUL when checked entering the turn, recovered and continued on with good courage to hold the show. LIL JOHN PAUL was chasing the pace three wide when bumped by CANDI'S HALO entering the turn, continued to chase the pacesetter three wide into the stretch but didn't do enough late. HEMI HUGHES outrun after hesitating at the start, closed ground late without threatening. JOHARLINGTON chased the pace, then was checked to avoid running up on CANDI'S HALO entering the turn, saved ground into the stretch and was outfinished. FULL OF EXPRESSION rated off the pace, raced three wide around the turn and tired. BLACK JACK COUNTY raced three wide and was not a factor. The rider of CANDI'S HALO lodged an objection against the rider of KIPPY KAT for alleged interference entering the turn and the trainer of JOHARLINGTON lodged an objection against the rider of LIL JOHN PAUL for alleged interference entering the turn. Both claims of foul were not allowed.
