**Footnotes**

JOHNNY'S GALAXY reserved racing along the inside, angled out leaving the turn, rallied to gain the lead at the sixteenth pole, then edged away. SWEETSOUTHERN TOWN chased the pace, moved to take over on the far turn, made the pace to the sixteenth pole, then couldn't stay with the winner while continuing on gamely for the place. BE MY FRANKENSTEIN stalked the pace three wide, made a run to join the leaders racing into the stretch but didn't do enough late. BLUE KING rated off the pace, rallied four wide around the far turn to loom a threat entering the stretch, then flattened out. GUILTYGUILTYGUILTY allowed to settle, swung out for the stretch run and had no late response. ERUPTION ZONE unhurried early, swung wide for the stretch run and never threatened. KING OF POP saved ground to no avail. TEMPESTUOUS ONE set the pace along the inside to nearing the quarter pole, then faltered. RUN WILKO RUN was through after a half mile.
