MS. REPRIZED prompted the leader outside from the three path, gained command leaving the eighth pole, and drew off under urging. CUCHU broke out slightly, set the pace while under pressure from MS. REPRIZED, and relinquished the lead midstretch to be second best, while no match for the winner. LUNAR EXPLOSION rated off the pace along the inside, angled wide for the stretch run and lacked a late response. TACTICAL MOVER was never a factor. LEONA'S DR. was steadied from between rivals at the start, and outrun.
