WESTERN LAWYER quickly sprinted to a clear lead while angling over to the inside, made the pace into the stretch, then increased his margin to the wire under urging. ALFIE COME HOME tracked the leaders three wide around the turn, then closed to gain the place while no match for the winner. PULPO chased the winner off the rail into the stretch and gave way. STRAIGHTEN MY HALO failed to menace. RIVERSTAR rated off the pace, raced three wide around the turn and tired. PRETTY ROWDY was outrun. MY OMEGA RUN steadied on the backstretch, raced three wide around the turn and faltered. CASCI saved ground and faded.
