HAWAIIAN CRUISE showed speed off the rail, opened a clear lead on the turn, then was fully extended to maintain her advantage to the wire. SPLIT THE CLOUDS pressed the pace along the rail, was steadied from inside HAWAIIAN CRUISE entering the turn, chased that rival into the stretch but couldn't gain on that while proving best of the rest. NORTHBOUND EXPRESS outrun early, swung wide for the stretch run and closed to gain the show. LOLA'S RIDGE failed to menace. LADY ALLEGRA was outrun. DARLIN MCKENNA broke through the gate prior to the start, chased the pace around the turn, then faltered. The trainer of SPLIT THE CLOUDS lodged an objection against the rider of HAWAIIAN CRUISE for alleged interference entering the turn. The claim of foul was not allowed.
