CITIZEN ADVOCATE showed speed along the inside, drew well clear in the stretch, then just failed to last. YARA tracked the pace along the inside into the stretch, then didn't do enough late while gaining the show. AWESOME BELLE chased the pace off the rail into the stretch and gave way. SINISTER TALE raced four wide and failed to menace. WHO IS CAMILLE rated off the pace, raced four wide around the turn and tired. REDBUD ROAD chased the pace three wide around the turn and tired. MY DUE PROCESS showed early foot along the inside, then steadied entering the turn and faltered. BULERIA raced three wide and faded.
