THE PARTY'S OVER vied for the lead off the rail, then drew away through the stretch when roused. EDGE AHEAD reserved off the pace, raced three wide around the turn, then closed to be up for the place while unable to stay with the winner. ROYAL CRIMSON allowed to settle, passed tired rivals to gain the show. BLACK JACK COUNTY raced with the pace along the rail, was steadied on the turn, then couldn't keep pace with the top ones in the drive. LONGER TERMS DOUG broke poorly, rushed up to reach contention, made a run along the inside on the turn to reach near even terms for command, then gave way in the drive. J'S REDBUD SPIRIT vied for the lead three wide to nearing the quarter pole, then tired. FLIGHT TO FREEDOM vied for the lead four wide into the turn, then faltered. PRODIGIOSO was not a factor. TOUGH LOOK showed brief speed along the rail and dropped back. WISE BLITZ tracked the pace into the turn, then faded. GUIDING SPIRIT was outrun.
