### Footnotes

BABY GITANA reserved along the inside after bumping with AGGIE H at the start, angled three wide midway of the far turn, rallied to catch LYNN'S IMAGE nearing the eighth pole, then drew clear. PRINCESS AT PEACE rated off the pace, advanced into contention off the rail around the far turn, then closed to prove second best while being outfinished by the winner. LYNN'S IMAGE set the pace along the inside into the stretch and gave way. AGGIE H allowed to settle after bumping with BABY GITANA at the start, advanced off the rail around the far turn to reach the attending position racing into the stretch, then tired. BRILLADORA up close early, faltered. COUNTY TYRONE chased the pace to the far turn, then had nothing left. KISS ME AGAIN chased the pace along the rail into the far turn and stopped.
