SWEETEST ELVIRA off slowly, chased the winner into the stretch, then couldn't match strides with that rival while being edged for the place. RUTHLESS REBECCA was not a factor. DIGITAL DELIGHT raced three wide and tired. LITTLE LUCIFER showed early foot and faltered. LYNI DE LOU up close racing along the inside, steadied from tight quarters entering the turn, then faded.
