Footnotes

HOOPLA quickly moved to the fore, made the pace off the rail into the stretch, then increased his margin to the wire when asked. NINEINTHENINE stalked the pace three wide into the stretch, then couldn't keep pace with the winner while gaining the place. MACHO'S WILDCAT stalked the pace along the inside, eased out leaving the far turn and had no response when asked. MIMITO BOY well placed racing along the rail, weakened in the drive. SARATOGA MATT rated off the pace, clipped heels on the far turn and failed to recover. SKY VENTURE stalked the pace between horses into the stretch, then gave way. SERAPI CAT reserved off the pace, raced three wide and tired. THANK U PHILIPPE allowed to settle, steadied to avoid running up on SERAPI CAT on the far turn and was not a factor. There was a stewards inquiry into the incident on the far turn. No action was taken.
