NOT IN ORDER chased the pace three wide into the stretch, then rallied under pressure to be just up at the wire. ZONA'S ZIPPER pressed the pace outside TWILIGHT MIRAGE, moved to gain a slim lead in the stretch and and just failed to last in a game effort. LARK'S IMPRESSION steadied inside NOT IN ORDER approaching the end of the backstretch, angled to the rail leaving the turn and rallied to reach near even terms for command inside the eighth pole but didn't do enough late. CRIMSON NATIVE bumped with GABY G and steadied on the backstretch, raced in striking position into the stretch and lacked a rally. TWILIGHT MIRAGE set the pace under pressure along the inside, then tired in the drive. SUPERBOWL PICC lunged at the start and was not a factor. GABY G was outrun after bumping with CRIMSON NATIVE and being steadied on the backstretch. The rider of LARK'S IMPRESSION lodged an objection against the rider of NOT IN ORDER for alleged interference on the backstretch. The claim of foul was not allowed.
