CATHY'S CRUNCHES vied for the lead along the inside to nearing the stretch, then drew off under pressure. DAISEY LEE chased the pace three wide, made a run to try CATHY'S CRUNCHES on the turn but was no match for that rival in the drive. ONLYONEANNA vied for the lead outside CATHY'S CRUNCHES, was caught in tight midway of the turn, angled out and couldn't keep pace with that rival while gaining some ground on the runner-up. RUNAWAY JOAN tracked the leaders along the rail around the turn and tired. INDY'S PRIDE rated off the pace, raced three wide around the turn and faltered. EVIL GARDEN saved ground to no avail. FLY BYE WILDCAT reserved off the pace, faded leaving the turn. BLANCA LUNA was outrun. REFLECTING POOL showed little. The rider of ONLYONEANNA lodged an objection against the rider of DAISEY LEE for alleged interference on the turn. The claim of foul was not allowed.
