B L'S NOISE showed speed along the inside into the stretch, then drew off when asked. PRINCE JOSHUA rated off the pace, raced three wide around the turn and closed to prove best of the rest. CITY OF BENARES reserved early, passed tired rivals to be up for the show. RED HOT CANDY chased the winner into the stretch and tired. GHOST FIVE chased the pace along the rail around the turn, then faltered. DECAF AGAIN was not a factor. FEDERER EXPRESS was outrun after ducking in at the start.
