Footnotes

I GO THROUGH reserved racing along the inside, swung out for the stretch run, rallied to gain the lead just inside the eighth pole, then drew clear under urging. SCORE ONE FOR ROSE stalked the pace along the inside, slipped through at the top of the stretch to gain the lead, made the pace to past the eighth pole, then couldn't match strides with winner while holding the place. CAPT. ZIPPOUNAS vied for the lead three wide to the top of the stretch, then gave way. GREAT BEAR unhurried early, raced three wide around the far turn and improved his position without threatening. TOTAL REWARD saved ground and failed to menace. MY SAINT chased the pace four wide, made a run to gain a brief lead on the far turn, then tired in the drive. HOPE DEFERED vied for the lead off the rail to the top of the stretch and tired. FORBIDDEN DANCER was not a factor. ROAD TO BABYLON tracked the pace into the far turn and faltered. MACHO'S WILDCAT wide while tracking the pace into the far turn, faded, was eased in the final eighth and vanned off.
