R OBSESSION outrun early, swung wide for the stretch run and rallied under pressure to be up late. YOU GLITTER GIRL set the pace along the rail, shook off CUTE CONNIE racing into the far turn, opened a clear lead in early stretch but couldn't resist the winner late. SHESADORABULL well placed after lunging at the start, eased out for the drive and closed to gain the show. APPEALING POND unhurried after being checked when rank in the early going, made a run four wide on the far turn to reach contention but didn't do enough late. COVINCING stalked the pace three wide into the stretch and tired. LILLY'SOFTHEFIELD off slowly, was reserved in striking position into the stretch but had no late response. MICKEY'S QUEENMARY failed to menace. MISS IDA BELLE tracked the pace along the rail into the far turn, then faltered. TASHA SANGUE steadied along the inside on the first turn and was not a factor. CUTE CONNIE chased the pace after bobbling at the start, made a run to reach near even terms for command racing down the backstretch, then faded.
