Footnotes

SUNSATONAL rated off the pace, angled three wide on the far turn while moving into contention, rallied to gain the lead nearing the eighth pole, then drew off. UNTUTTTABLE AFFAIR outrun after being checked from tight quarters at the start, rallied to be up for the place while no threat to the winner. TRIAL stalked the pace, moved to gain a brief lead in early stretch, then couldn't match strides with the winner and was edged for the place. MOUNTAIN MYTH unhurried early, improved his position without threatening. COPPERCAT LEGACY set the pace along the inside into the stretch and tired. PARLAY PETE tracked the pace three wide to nearing the stretch, then faltered. DISTINCTIVE RIDGE chased the pace for a half mile and faded. SHARETHEHONOR was done early. STORM'N DILLION reserved off the pace, stopped and was eased in the stretch run.
